### Part B. CV SUMMARY (max. 5000 characters, including spaces)

Dr. Marco Garrido is a Full Professor [Catedrático de Universidad] of the Department of Physical Geography and Regional Geographic Analysis at the University of Seville and a founding member of the research group Health and Territory Research (HTR, PAIDI HUM-981). With an extensive academic and research career, he specializes in Health Geography (UNESCO Code 250506), focusing on Urban Health, Mental Health, Environmental Justice, Social Inequalities, and Health Policies. Dr. Garrido has an outstanding scientific output, with over 65 articles published in indexed journals (WoS/Scopus), 10 books, and 10 book chapters with prestigious publishers like Routledge, Springer, and WHO. His work has been presented at more than 120 international conferences, with an h-index of 19 (WoS/Scopus) and 25 (Google Scholar), and over 2,500 citations across different platforms. He has directed or supervised 9 Ph.D. theses (3 completed, 6 in progress) and more than 100 academic theses (Bachelor's and Master's). He holds 4 six-year research terms ['sexenios'], including one in knowledge transfer ['transferencia'] and 3 five-year teaching terms ('quinquenios'). Dr. Garrido has participated in more than 35 research projects, serving as the principal investigator in 6 competitive projects and over 10 knowledge transfer contracts. Notably, he has led ground-





breaking studies such as the Atlas of Axial Spondyloarthritis in Spain (2017), the Atlas of Migraine in Spain (2018), and The International Map of Axial Spondyloarthritis (IMAS), implemented in 27 countries. He has also coordinated major R&D+i projects, including URDIS, GreenAndCITIES, GreenTEENS, and the Erasmus+ CISCOS project under the Knowledge Alliances program of the European Commission. Dr. Garrido's international experience is extensive, with research stays at institutions like the World Health Organization (WHO) in Geneva, FAO (Rome), Columbia University (USA), Maynooth University (Ireland), and the Universidade Federal do Rio de Janeiro (Brazil). While at WHO, he contributed to global projects such as the WHO Mental Health Atlas, Neurological Disorders: Public Health Challenges, and the Atlas of Multiple Sclerosis Resources in the World (2008). A recognized expert in Health Geography, Dr. Garrido combines applied research, knowledge transfer, and international collaboration to address global challenges in health and territorial planning. Recently, he became a member of the IUCN WCPA Health and Well-Being Specialist Group Advisory Committee.
