Part B. CV SUMMARY (max. 5000 characters, including spaces)

The continued quality of my research activity is underlined by 3 consecutive 'sexenios' (latest in 2022) plus over half the scholarly production required for a 4th (cf. 1, 2, 3 in C.1), as well as the positive evaluation of research excellence by the AQUIB in 2017 and 2023.

I have produced over 60 publications in international journals with recognized quality indices and in volumes published by prestigious academic publishers with rigorous selection criteria and processes: Cambridge University Press, Edinburgh University Press, Rodopi, Benjamins, De Gruyter, Springer, and Peter Lang. I have also contributed to more than 80 specialized conferences, including AEDEAN (20 presentations and the organization of 1 roundtable), ICAME (6 presentations, co-organization of a workshop, and invitation as a plenary speaker), SLE (4 presentations), CILC (5), ICEHL (3), BICLCE (4 presentations and the co-organization of a workshop), AESLA (2 presentations), among others.

Between 2004 and 2011 my scholarly production focused on historical syntax from a variationist perspective. From 2011 onwards, given my experience in variationism and sociolinguistics, I have worked on morphosyntactic variation in emerging varieties of English. This new line of research gave rise to the ViEW research group (Variation in English Worldwide), currently consolidated thanks to continuous funding from the Ministry since 2011. The high quality of my academic production can be seen in the national and international impact it has had. For example, (i) I was invited to contribute two chapters to the handbook *New Cambridge History of the English Language* (CUP); (ii) I was appointed as a member of the Executive Committees of AEDEAN and ICAME; (iii) I have actively collaborated with international researchers at prestigious research centers, such as S. Buschfeld (TU Dortmund), M. Krug (Bamberg U.), M.G. Sanchez (Gibraltar National Book Council) and E. Schneider (Regensburg U.), the first three of whom form part of our work team. My capacity in

the area of training is reflected in the number of PhD dissertations I have supervised over the last 8 years (1 defended, 1 to be defended in September 2025, and 3 ongoing) and in the optimization of public resources: the two predoctoral contract holders from earlier MINECO projects defended their PhDs within 3 years *cum laude* with international mentions and took optimal advantage of their final year as postdoctoral researchers.

As my personal website illustrates (view0.webs.uvigo.es/team/cristinasuarez) I have published several articles and a chapter on related lines of research, such as language contact, language assessment, and multimodal discourse analysis. The latter study was carried out under the auspices of two research projects based at public institutions: the Instituto Galego de Consumo (1998-2000, EU DEXXIV) and the 'Cátedra de Violencia de Género, UIB' (2007-2008). Both of these had social impact in that they examined, through presentations and publications, how advertising can influence people by appealing to emotions, especially more vulnerable social groups like children and women in abusive situations. Their respective titles are "Design and accessibility of baby food labels from the consumer's point of view" and "Advertising and gender violence: a multidisciplinary study".

Regarding my teaching activities, the quality of this is demonstrated by 4 'quinquenios' (the latest in 2022) and the positive acknowledgement of my teaching made by the AQUIB (2022). Since joining the UIB, I have been teaching full-time courses in Morphosyntax, History of English Language, and Language Variation and Change. My teaching also includes postgraduate courses at the MA and Doctorate levels with subjects on diachronic linguistics, corpus linguistics, variation, and linguistic change, both at the UIB and as an invited teacher at the Univ. Autónoma de Nuevo León (Mexico) (2009), and at the Universidade de Vigo (2015). The breadth of my teaching experience has also been enhanced through my participation in 4 educational innovation projects at UIB (2006-2007, 2009-2010, 2010-2011, 2014-2015). The connection between my teaching and research guarantees that all teaching incorporates the latest research in order to attract young researchers, as demonstrated by the publication of 1 article derived from a BA thesis, as well as a further 2 currently in the process of publication; all of these have been supervised by me.
