Manuel García Ramírez, PhD in Psychology by Universidad de Sevilla (US), Full Professor at the US Dept. Social Psychology and founder of CESPYD, the Center of Community Research and Action at the US (PAIDI HUM873). From 2012 and 2018 I was the coordinator of the US Official Master “International Migrations, Health and Wellbeing: Intervention Models and Strategies.” Since 2012 I have been the coordinator of the research line “Psychosocial processes, culture, diversity and citizenship” of the PhD Programme in Psychology at US. I am Fellow of the Society for Community Research and Action (SCRA, 27th Division of the American Psychology Association), Member of the International Academy of Intercultural Research as well as member of the scientific committee of the Task Force on Migration, Equity and Diversity promoted by the WHO network Health Promoting Hospitals. I am an invited expert of the European Platform for Roma inclusion by the European Commission to develop the white paper on Roma health and housing for the European Union. In the last ten years I have actively led and participated in some of the more relevant research initiatives in the field of public health and vulnerable and ethnic minorities groups, funded by important institutions such as the Spanish R+D programme, the International Organization for Migration, the Open Society Foundations, the European Commission’s DG JUST and DG SANTE, and the ADAPT and HOME COST networks.
